

betcha Giveaway - Terms and Conditions

1. All Entrants (“Entrants”) who participate in this Betcha Ticket Giveaway Competition (the “Competition”) are deemed to accept these terms and conditions of entry. Any entries in this Competition that do not comply with these terms and conditions will be deemed invalid and Entain New Zealand Limited (“betcha”) takes no responsibility for such entries. All times given in these terms and conditions are references to New Zealand Local Time and all references to currency are referring to New Zealand Dollars.

2. betcha is the promoter of the Competition. The Promoter’s Head Office is at Level 10, Asteron Centre, 55 Featherston Street, Wellington, Pipitea and the Promoter’s phone number is: +64 4 576 6999.

Competition Period

2. The Competition will commence at 09:00AM Tuesday 14th October 2025 and concludes at 11:59PM Saturday 1st November 2025 (the “Competition Period”).

Eligible Entrants

3. To be eligible for entry into this Competition all Entrants must:

- (a) Be eighteen (18) years of age or older;
- (b) Be a betcha account holder; and
- (c) Be able to attend the relevant Auckland FC match as described on the Competition Website.

4. betcha reserves the right to require any Entrant to produce identification to verify their age or identity.

Competition Entry

5. An Entrant will earn one (1) competition entry (a “Competition Entry”) by entering promo code “AFC” on the Promotions Page and then placing any bet on the Auckland FC vs Melbourne Victory match on 18 October 2025.

6. An Entrant may earn an additional Competition Entry by entering their betcha account number and Auckland FC Membership number on the Competition Website where indicated.

7. An Entrant may earn a maximum of two (2) Competition Entries.

8. Multiple Entries will not result in any additional Competition Entries beyond the maximum of two (2).

Prize Draws

9. After the Competition Period, on Saturday 1st November 2025 at or before 12:00PM on the Monday of the week of the Match, a draw will take place from all valid Competition Entries (a “**Prize Draw**”), in the presence of a designated representative of betcha, to determine the “**Prize Winner**”. The final decision in respect of the Prize Draw will be at the sole discretion of betcha and no correspondence will be entered into.

10. There will be only one (1) Prize Draw and there is only one (1) Prize Package to be won.

11. Betcha will contact the Prize Winner via text message to the phone number supplied as part of their Competition Entry. Entrant’s must respond within 12 hours in order to claim the Prize. Entrants’ are responsible for ensuring their details are correct.

12. If betcha cannot contact a Prize Winner within 24 hours of the Prize Draw, it reserves the right to redraw an alternative Prize Winner on the same terms as the original Prize Draw. No correspondence will be entered into.

Competition Prize

13. The Prize Winner will win:

- Walking bus to match with Auckland FC;
- Invitation to post-match celebration to be determined by betcha in its sole discretion;

(the **Prize Package**)

14. Each Prize Winner and their Prize Companion must be over 18 in order to attend. Any Prize Winner or companion who is under 18 will not be allowed access.

17. If the Prize is unavailable for any reason, betcha, in its sole discretion, reserves the right to substitute the Prize with a prize to the equal monetary value. The Prize cannot be exchanged for cash or other products or services, or otherwise transferred or modified.

General

21. (a) Any "excluded customer" of betcha (being a customer who has self-excluded from betcha's products, as well as any customer who has been excluded by betcha); and

(b) betcha employees, agents (and agent's employees) and contractors of betcha and the "Immediate Families" of such persons.

25. If this Competition cannot be run as planned for any reason, including for reasons beyond the control of betcha, betcha reserves the right in its sole discretion to cancel, terminate, modify or suspend this Competition (or any part of this Competition), at any time.

26. betcha takes no responsibility for any inability to enter, complete, continue or conclude the Competition (or any part of the Competition) due to equipment or technical malfunction, Acts of God or otherwise.

27. Except for any liability that cannot be excluded by law, betcha and any person in connection with this Competition are not liable for any direct, indirect, special or consequential loss or damage whatsoever suffered or personal injury suffered or sustained in connection with:

- (a) Registration for or participation in this Competition;
- (b) The use (or non-use) of any part of the Prize Package; and
- (c) The administration of this Competition.

28. Failure by betcha to enforce any of its rights under these terms and conditions at any stage does not constitute a waiver of those rights.

29. Any personal information provided by an Entrant in participating in this Competition will be held in accordance with the Privacy Act 2020. The information collected and held by betcha about you may be used by betcha from time to time to:

- (a) Administer this Competition and verify compliance with these terms and conditions;
- (b) Ensure fairness and the integrity of this Competition;
- (c) Provide you with notifications, reminders and offers;
- (d) Assess your eligibility to receive specific products and services;
- (e) Offer you products or services that betcha considers may be of interest to you;
- (f) Assess your eligibility for participation in any promotional events which betcha may be running;
- (g) Carry out general market research and analysis relating to betcha's products and services generally;
- (h) To invite you to participate in surveys, sweepstakes, Competitions and similar promotions

30. betcha may match or combine the personal information that you provide when entering this Competition with other personal information about you that betcha has obtained from other sources or that may already be on betcha's records, whether that information was collected online or in physical form, and may use information already held in the administration of this Competition.

31. Pursuant to the Privacy Act 2020, you have the right to view the personal information you have provided when entering this Competition. You may also request to review and correct any of that personal information by contacting betcha. Additional rights may apply under applicable law.

32. By entering this Competition, an Entrant agrees to receive marketing and promotional material from betcha and its authorised agents (including electronic material).

33. Entrants into this Competition agree that betcha may disclose the Entrant's personal and Competition Entry information to third parties in connection with any of the purposes stated under

condition 29, provided the recipient of the information is subject to an obligation of confidentiality in relation to the disclosed information.

34. Notwithstanding condition 33, betcha may disclose your personal information to particular organisations both within New Zealand and overseas for the purposes of investigating and/or detecting breaches of any relevant legislation or New Zealand, or of another jurisdiction.
