

betcha A-League Grand Final Giveaway Competition - Terms and Conditions

1. All Entrants (“**Entrants**”) who participate in this betcha A-League Grand Final Giveaway Competition (the “**Competition**”) are deemed to accept these terms and conditions of entry. Any entries in this Competition that do not comply with these terms and conditions will be deemed invalid and Entain New Zealand Limited (“**betcha**”) takes no responsibility for such entries. All times given in these terms and conditions are references to New Zealand Local Time and all references to currency are referring to New Zealand Dollars.

Competition Period

3. The Competition will commence at 6:00AM Wednesday 20 May 2026 and conclude at 12:00PM Friday 22 May 2026 (the “**Competition Period**”).

Eligible Entrants

4. To be eligible for entry into this Competition all Entrants must:
 - a. Be eighteen (18) years of age;
 - b. Reside in New Zealand;
 - c. Hold a betcha account with betcha during the Competition Period;
 - d. Not be suspended, banned or deemed promotion-ineligible by betcha for any reason.

Competition Entry

 - h. To invite you to participate in surveys, sweepstakes, Competitions and similar promotions
