

Betcha Touchdown Factory Multi Promotion Terms and Conditions

1. General

1. These terms and conditions apply to the **Betcha Touchdown Factory Factory Promotion** conducted by Entain New Zealand Limited, NZBN 9429051295158, as delegate of TAB New Zealand, trading as Betcha, of Level 10, Datacom Centre, 55 Featherston Street, Wellington, New Zealand (**Betcha, BETCHA, we, us, our or Promoter**).
2. By participating in this promotion, entrants are deemed to accept these terms and conditions, BETCHA's general terms and conditions, BETCHA account terms, and any applicable betting rules.
3. All times in these terms and conditions are New Zealand local time unless stated otherwise. All references to currency are references to New Zealand dollars.
4. This promotion is a game of chance. Chance plays the only role in determining prize winners.
5. This promotion is not sponsored, endorsed, administered by, or associated with the NFL. Entrants provide their information to BETCHA.
 - (a) This promotion is not sponsored, endorsed, administered by, or associated with, Meta (Facebook or Instagram).

2. Promotion Period and Entry Windows

6. Each Entry Window will have a corresponding Draw (see clause 25). Entries can only be earned by placing Qualifying Answers on Eligible Competition Posts during the relevant Entry Windows set out below.
7. The promotion will have one opportunity for posted on Betcha's Facebook and Instagram pages entry for each round of the 2026-27 NFL regular season, which may be extended to the playoffs and/or Super Bowl, in the form of organic posts on each platform clearly identified as the promotion entry point (**Eligible Competition Posts**).
8. Entries will be segmented across the following Entry Windows:

9. Entries must be made on the Eligible Competition Posts for the relevant Entry Window prior to the advertised cutoff. Late entries will not be accepted. Cutoff dates and times may be extended by express communication on that Entry Window's relevant Eligible Competition Post.
10. BETCHA may amend the list of Factory Multi, Entry Windows or Draw Dates if a round or relevant NFL match is postponed, cancelled, abandoned, rescheduled, or otherwise affected by circumstances outside BETCHA's reasonable control.

3. Eligible Entrants

11. Entry is open only to New Zealand residents who, at the time of entry and at the time a prize is awarded:
 - (a) are 18 years of age or older;
 - (b) hold a valid Betcha account;
 - (c) are not self-excluded from BETCHA's products or services;

- (d) are not suspended, banned, closed, restricted, excluded or otherwise deemed promotion-ineligible by BETCHA;
 - (e) are not subject to a BETCHA promotional exclusion, bonus exclusion, safer betting exclusion, or similar account restriction;
 - (f) are not using a BETCHA account for syndicate, commercial, group or other unauthorised use; and
 - (g) otherwise comply with these terms and conditions and all other terms and conditions associated with use of a BETCHA account.
12. BETCHA reserves the right to require any entrant to provide identification or other information to verify their age, identity, residency, account status, eligibility, and compliance with these terms and conditions.
13. The following persons are:
- (a) not eligible to enter or win a prize:
 - 1. persons BETCHA reasonably determines should be excluded for legal, regulatory, integrity, safer betting or operational reasons.
 - 2. employees, contractors, agents, officers and directors of BETCHA, Entain New Zealand Limited, TAB New Zealand, or any related company involved in the promotion;
 - 3. the immediate families of the persons listed in clause 13(a)(2); and
14. For the purposes of clause 13, **Immediate Family** means a person's spouse or partner (legal or de facto), parent, child, or sibling.

4. How to Enter

15. To receive an entry, an Eligible Entrant must comment a Qualifying Answer on an Eligible Competition Post during its relevant Entry Window.
16. In order to earn an entry, a comment on an Eligible Competition post must:
- (a) Attempt to respond to the question listed on the Eligible Competition post;
 - (b) Be an original work from the Eligible Entrant;
 - (c) Be respectful and appropriate for a public audience;
 - (d) Make no reference to inappropriate behaviour (including in relation to gambling); and
 - (e) Not contain anything that may be discriminatory, hateful, vilifying or of similar unsavoury character,
- a Qualifying Answer.**
17. Incoherent or otherwise non-compliant comments will not count.
18. A Qualifying Answer comment earns one entry into the relevant Draw for that Entry Window.
19. An entrant may earn a maximum of one entry per Eligible Competition Post. Additional comments on the same post will not generate additional entries.
20. Subject to the limitation of one entry per post, a person may enter each Entry Window of this Promotion.
21. Entry Windows for the post-season will only open if Betcha elects to extend this promotion past the regular season.
22. BETCHA's records are final and conclusive in determining whether an entry has been earned.

5. Prize Draws

23. There will be 18 (or 22, if extended) prize draws in total.

24. The Promoter will aim to conduct each Draw on the Tuesday immediately following the close of the relevant Entry Window. However, Betcha reserves the right to delay and reschedule any Draw.

26. Each Draw will be conducted randomly from all valid entries included in that Draw.
27. BETCHA may use a spreadsheet, random number generator, automated tool, or other randomised selection process to conduct each Draw.
28. BETCHA's decision in relation to each Draw, the validity of any entry, and the identity of any winner is final and no correspondence will be entered into.

6. Prizes

30. For each of the Draws, the pool is the profit (for clarity, this does not include the stake value of the Bonus Cash used to place the Factory Multi) of the Factory Multi described in the relevant Eligible Competition Post of that draw.
 - (a) For clarity, there will be no prize or draw where the relevant Entry Window's Factory Multi does not provide a return.
31. If this Promotion is not extended by Betcha to cover the NFL playoffs, the relevant Draws will not take place.
32. The Prizes consist of real cash, not Bonus Cash.
33. The total prize pool for the promotion is unknown as the value given away relies on the results of promotional wagers placed by Betcha.
34. Bonus Cash is not real cash and is not transferable, exchangeable or redeemable for cash or any other product or service (other than wagering with Betcha).
35. Bonus Cash is subject to Betcha's Bonus Cash terms and conditions and any other terms notified by Betcha.
36. Any Bonus Cash awarded as part of this promotion will expire 7 days after it is applied to the winner's Betcha account. Any unused Bonus Cash remaining after that time will be forfeited.
37. Betcha is not responsible if a winner fails to use Bonus Cash before it expires.
38. Betcha may substitute any prize with another prize of equivalent value if the advertised prize is unavailable for any reason.

7. Winner Notification and Prize Fulfilment

38. Winners will be notified after the relevant Draw by in-app notification, push notification, email, SMS, account message, or any other contact method BETCHA considers appropriate.
39. BETCHA will endeavour to notify winners as soon as reasonably practicable after the relevant Draw.
40. Prizes will be applied to the relevant winner's BETCHA account after the Draw within 72 hours.
41. It is each entrant's responsibility to ensure their BETCHA account details and notification settings are accurate and up to date. BETCHA is not responsible if a winner does not receive or read a notification.
42. If BETCHA is unable to apply a prize to a winner's BETCHA account, or if a winner is found to be ineligible, BETCHA may redraw the relevant prize on the same terms as the original Draw.

8. Safer Betting Review for Major Prizes

43. Before any \$5,000+ Prize from a Draw is awarded, the selected winner will be referred to BETCHA's Safer Betting team for review.
44. BETCHA may withhold, void or decline to award a \$5,000+ prize if, in BETCHA's reasonable opinion, awarding the prize would be inappropriate because the entrant:
 - (a) is not eligible under these terms and conditions;
 - (b) is subject to safer betting concerns;
 - (c) is self-excluded, excluded, suspended, restricted or otherwise promotion-ineligible;
 - (d) is reasonably considered by BETCHA to be at risk of gambling harm; or
 - (e) should not receive the prize for legal, regulatory, responsible gambling, integrity or operational reasons.
45. If a selected winner is deemed ineligible or unsuitable to receive a \$5,000+ Prize, that winner will forfeit the prize and BETCHA may conduct a redraw.
46. BETCHA may repeat the redraw process as many times as necessary until an eligible winner is determined.

9. Disqualification and Verification

47. BETCHA reserves the right, at any time, to verify the validity of any entry or entrant.
48. BETCHA may disqualify any entrant or entry if BETCHA reasonably considers that the entrant:
 - (a) has breached these terms and conditions;
 - (b) has breached any other terms and conditions associated with use of a BETCHA account;
 - (c) has tampered with the entry process or the Draw process;
 - (d) has acted fraudulently, dishonestly, unlawfully or in bad faith;
 - (e) has used a BETCHA account for syndicate, commercial, group or unauthorised use;
 - (f) has attempted to manipulate the promotion;
 - (g) is not an Eligible Entrant; or
 - (h) is otherwise ineligible to participate in the promotion.
49. If an entrant is disqualified, BETCHA may remove their entries, reverse or withhold any prize, and conduct a redraw.

10. Promotion Changes, Cancellation and Force Majeure

50. BETCHA may modify, suspend, cancel, terminate or delay the promotion, any Entry Window, any Draw, or any prize if the promotion cannot be run as planned for any reason beyond BETCHA's reasonable control, including but not limited to technical failures, system outages, fraud, tampering, match postponements, match cancellations, changes to the tournament schedule, regulatory issues, power failures, natural disasters, war, terrorism, civil unrest, epidemic, pandemic, or any other event beyond BETCHA's reasonable control.
51. BETCHA may make reasonable changes to these terms and conditions if the change is required for legal, regulatory, operational, integrity, safer betting or technical reasons, or if the change is likely to benefit entrants or be of immaterial detriment to entrants.
52. If BETCHA changes these terms and conditions, BETCHA will make the updated terms and conditions available in the same manner as these terms and conditions, or by any other method BETCHA considers appropriate.

11. Liability

53. Except for any liability that cannot be excluded by law, BETCHA, Entain New Zealand Limited, TAB New Zealand and their related companies, officers, employees, contractors and agents are not liable for any loss, damage, cost, expense or injury suffered or sustained in connection with:
 - (a) participating in the promotion;
 - (b) placing or attempting to place a bet;
 - (c) any technical issue, system failure, delay or error;
 - (d) any lost, late, incomplete, corrupted, misdirected or invalid entry;
 - (e) the use or non-use of any prize;
 - (f) any decision to disqualify an entrant or void an entry; or
 - (g) the administration of the promotion.
54. Nothing in these terms and conditions limits, excludes or modifies any rights an entrant may have under law that cannot be lawfully limited, excluded or modified.

12. Privacy

55. BETCHA will collect, hold, use and disclose entrants' personal information in accordance with the Privacy Act 2020 and BETCHA's privacy policy.
56. Personal information collected in connection with this promotion may be used by BETCHA and its related companies, contractors and agents for the purposes of:
 - (a) administering the promotion;
 - (b) verifying eligibility and compliance with these terms and conditions;
 - (c) conducting the Draws;
 - (d) notifying winners and applying prizes;
 - (e) safer betting, harm minimisation, fraud, integrity and risk management purposes;
 - (f) providing entrants with notifications, reminders, marketing and promotional material, where permitted; and
 - (g) complying with legal and regulatory obligations.
57. BETCHA may disclose personal information to its related companies, contractors, service providers, regulators, integrity bodies, safer betting teams and other third parties where reasonably necessary for the purposes described in these terms and conditions.

58. Entrants may request access to, or correction of, their personal information by contacting BETCHA using the details in BETCHA's privacy policy.

13. Marketing

59. By participating in this promotion, entrants agree to receive communications from BETCHA relating to the promotion, including in-app messages, push notifications, email, SMS or account messages.
60. Entrants may also receive marketing and promotional communications from BETCHA where permitted by law and in accordance with BETCHA's privacy policy and communication preferences.

14. Miscellaneous

61. Failure by BETCHA to enforce any of its rights under these terms and conditions does not constitute a waiver of those rights.
62. If any provision of these terms and conditions is found to be invalid or unenforceable, the remaining provisions will continue in full force and effect.
63. Currency values in this document are equivalent to NZD, unless stated otherwise.
64. These terms and conditions are governed by the laws of New Zealand. Entrants submit to the non-exclusive jurisdiction of the New Zealand courts.
